CORONAVIRUS (COVID-19) ADVICE FOR RIVER USERS

Following updated government guidance on outdoor activities, some restrictions on the private use of powered craft for leisure cruising on the above waterway were lifted from Monday 1 June 2020.

Lockdown in the UK is still in force but if you are the owner of a private use powered craft, you may now use it to take short day trips. Please check with your mooring provider as to whether they are permitting anyone onto their site before leaving home. You must return your boat to its home mooring at the end of the day and you cannot stay on it overnight. There are no restrictions on how far you may travel to access our waterways in England but you must travel in your own car, alone or only with members of your own household. Do not leave home if you or anyone in your household has symptoms of Coronavirus/Covid-19.

You may meet, outside, up to six other persons who are not members of your household but you must travel separately, adhere to social distancing rules and keep at least two metres apart at all times. The Government have clearly stated that it is far too early to make fundamental changes to social distancing requirements in relation to the Coronavirus emergency.

To stay safe, you must take hygiene precautions when you are outside. Good hand hygiene is essential to keep you and others safe and well. We encourage you to frequently clean your hands whilst you are on our waterways using an appropriate hand sanitizer or soap and hot water. Please wipe touch points using sanitizing wipes or a cloth with a small amount of sanitizing gel. Do not spray cleaning fluids or water onto control buttons or panels.

During the lockdown, we had to pause most non-essential navigation activity. We have now recommenced routine maintenance in line with government guidelines. Please adhere to all on-site instruction and signage and exercise caution when using our sites. Be patient at busy sites and follow any instructions in place at our assisted passage locks. Assisted lock passage must be booked by phone; please do not visit the site to book lock passage and do not approach lock offices on foot unless instructed by the lock keeper when you arrive to be locked through. When navigating, be wary of obstructions which may have been deposited over winter and report any problems you may encounter by ringing 0800 80 70 60.

Great Cornard Lock within this powered craft reach is owned and operated by the River Stour Trust and you need permission from the Trust to make passage: www.riverstourtrust.org tel: 01787 313199. Please make time to plan your journey and regularly check our Navigation Notices on www.visitanglianwaterways.org. Your craft must be properly registered for use on our waterways and you must adhere to navigation legislation and byelaws at all times. Significant or serious breaches of the coronavirus restrictions should be reported to the police on 101 or the local police website, as they have powers to deal with people breaking coronavirus rules.

At this time, in line with government guidance, commercial use of our waterways (hire boats etc.) is not yet permitted.

Please enjoy the use of the navigation in a responsible way. Stay alert and stay safe as we continue to respond to the challenges of coronavirus.
